HOW TO ACCESS INTERNET BANKING

• Log on to HFC Bank's website www.hfc.com.fj:

https://ibs.hfc.com.fj/mvphfc/default.aspx

- The green bar appearing on the login page will confirm that you have logged onto a genuine, secure website.
- Enter Member Login code.
- Enter Password.
- When prompted, change password (choose a new, strong alpha-numeric password which can consist of 8 to 16 characters, a mixture of upper or lower case with at least one number, and special characters with the exception of percentage button (%).
- Read and accept Terms & Conditions. (Note that Internet Banking Terms & Conditions can be accessed on our website).
- You may change your password at any time by selecting 'My Preference' menu from internet banking.

BUSINESS VIEWPOINT

An additional feature called BUSINESS VIEWPOINT has been added to HFC Bank's Internet Banking service. Business Viewpoint option will mainly benefit Business customers. It provides the option for Business customers to nominate an ADMINISTRATOR who can assign transactional and non-transactional tasks to Signatories and Operators on Internet Banking, without contacting HFC Bank.

Pre-requisites:

- In order to have access to Business Viewpoint option, customers must complete the Business Internet Banking Registration Form. Existing customers may complete a Business Maintenance Form.
- Business customers may appoint an Administrator who must be a Signatory on the account.
- A Member Login code and Password will be issued to the Administrator by HFC Bank.
- Only the Administrator will have access to the Business Viewpoint screen where he/she can create or delink logins for other signatories/operators of the Entity.

Advantages of using Business Viewpoint:

- The option to nominate an Administrator. (An Administrator can only be created/ cancelled by HFC Bank).
- The Administrator will have the ability to:
 - Create and issue Internet banking Login codes and Passwords to other Signatories/Operators of the Business account without having to contact HFC Bank.
 - 2. Assign various access levels to Signatories/Operators on Internet Banking (Full Access/View Only).
 - 3. Cancel Internet Banking access for Signatories/Operators.
 - Change and re-issue Passwords at any time for own self or for Signatories/Operators without contacting HFC Bank.
- Business (and Personal) customers with mode of operation '2 or more to sign conjointly' on an account can now utilize the STORE button to save transactions which need authorization by other Signatories according to mode of operation on the account.
- Signatories are able to login at different times and from different locations to authorize pending transactions.
- Allows up to 7 consecutive days to authorize pending transactions. (Pending requests will be purged on 8th day if not duly authorized).



Administrator's First Login to Internet Banking:

- To log in, follow the steps given under heading 'How to access internet banking'.
- Note, at Administrator's first login, the Business Viewpoint screen will open automatically after change of password. (Only the Administrator will always have access to this screen).
- Thereafter the Administrator may log in and select ACCOUNT OPTIONS menu and select Business Viewpoint from the dropdown list. Only the Administrator will have the ability to open and view all the details on this screen.
- At first login to Business Viewpoint, the Administrator will view a list of names for all the authorized Signatories (also known as Authority To Operate or ATOs).
- Authorization Limit will show as 'None'. Accessible accounts will also display 'None' for all the Authorised Users
- 2 options appear under 'Actions' heading for each Signatory: Modify and Access Codes.
- Select 'Modify' to first change Administrator's own access level from 'None' to 'Full access'
- In the 'Authorization Limit' field, enter the amount for limit per transaction (daily total for which must not exceed the standard Daily Limit of \$10,000 or the approved Daily Limit).
- Enter own Password to authorize the change.
- Proceed to modify access levels and limits for all other Signatories displayed on the list.
- Select 'Access Code' option for each signatory to create and issue login codes i.e. Member Login Code and Password for each Signatory.
- Data Entry Users, also known as Operators, are non-signatories on a Business account.
- An Administrator has the ability to create/delete an Operator, and issue login codes to Operators to view balances, prepare entries for Wages & download statements on internet banking.

Transfer of Funds – Business Accounts & Personal Joint Accounts (2 or more to sign conjointly):

- Personal Joint account holders are not required to nominate an Administrator.
- Each signatory on a Personal Joint account will be issued a Member Login code and Password by HFC Bank. They may contact the Bank when a new Password is required (if forgotten).
- The Signatory of an account where 2 or more are required to sign conjointly can initiate a transfer of money request and use the STORE button to save the request for other Signatories of the account to authorize.
- The other Signatories can logon to internet banking and view the Pending Authorization request on the Home page or click on PAYMENTS Menu and select Authorization Requests.
- They can select Details to view full details of the transfer request before entering their password to authorize the request.
- The transfer money request will be processed when the required number of Signatories have entered their passwords and authorized the transaction.
- Cut-off times are 11am and 2pm Monday Friday (not including public holidays). This applies on all transfers to other banks.
- The same process applies to Business accounts for authorizing a transfer of funds request if mode of operation is 2 or more to sign conjointly.

*If Pending Authorizations are not actioned within 7 days, the request will be purged/ deleted.

	HFC Bank's Bill Pay	Will allow customers to pay Bills to registered Billers by selecting a Biller from the dropdown list.
	Transfer Money	Allows transfers between own linked accounts, to other accounts within HFC Bank and to other Banks in Fiji. Note: Transfers to Other Banks may be updated on the next Business day.
	Account Address Book	Store details of regular payees that you are likely to make payments to more than once e.g. monthly Rent etc.
	HFC Bank's Bill Pay Address Book	Store details of regular HFC Bank's Bill Payments that you are likely to pay more than once.
	Multiple Transfers	Allows regular payments to Internal and External accounts through Batch processing.
	Authorization Requests	This section displays transactions which are pending and awaiting authorization by other signatories of the account.



Inbox	Alerts	Provides customers with a facility to be automatically notified via SMS or Email, when a variety of actions occur relating to their accounts.	
My Preference	Change Password	Allows change of password at any time. (If password is forgotten, please contact HFC Bank Call Centre for a new password).	
Account Options	Personalise Account Names	Enables change of account names to easily identify similar accounts e.g. 2 Savings accounts (Currently not available).	
	Organise Accounts	Allows you to change the account number you want displayed on the summary shown on Home Page	
	Business Viewpoint	For an Administrator's access only - on Business accounts.	
Services & Help	Help	A pop-up window which displays information for each menu bar on HFC Bank Internet Banking, including BSB Numbers for other banks.	
	Stop Cheques	Allows 'Stop' notice to be placed on lost or stolen cheques or cheque books.	
	Order Cheque Book	Allows ordering of Cheque Books.	
	Setup Security Options	Self-register here to receive SMS One Time Password on your mobile phone for each login to Internet or Mobile Banking. A monthly fee applies.	
	Stop Mobile Banking	Disable Mobile Banking access by selecting this option on Internet banking.	
	BSB Information	Displays a list of linked accounts with HFC Bank BSB Number.	

HOW TO ACCESS AND MAKE HFC BANK BILL PAYMENTS

 Go to the Accounts or Payments Menu tab and select HFC Bank's Bill Pay option.

- Select your HFC Bank account number to pay the Bill.
- In the Biller detail section, select 'Pay New Biller' if you are paying a Biller for the first time. Enter the first 3 digits of the Biller name in the 'Search for a Biller' box e.g. enter W-A-T if paying Water Authority of Fiji for the first time. Click on search button. Immediately Biller details for Water Authority will appear. Thereafter you will be able to view Water Authority details in your drop-down list of Billers under HFC Bank's Bill Payment. The same process will apply for each new Biller you will pay for the first time.
- Enter your Customer Reference Number provided by the Biller in the box labelled 'Reference'. (This number should appear on your Statement Bill from the Biller)
- Please ensure to enter the correct reference number to avoid disputes regarding non-payment of bills and possible dis-connection of service.
- Enter the amount for payment.
- Confirm the date you want HFC Bank's Bill Pay to be processed on i.e. you
 can select the option to pay 'Now' or you can schedule the payment to be
 processed at a future date; however the date you select must be within the next
 sixty (60) days.



- Please check that all the details of your payment transaction is correct. .
- Submit and confirm the HFC Bank's Bill Pay.
- Record or print the confirmation receipt number for future reference.
- Please note that all your HFC Bank's Bill Pay requests can be saved under 'HFC Bank's Bill Pay Address Book' option in the Payments Menu.
- Once the payment transaction is successful, your HFC Bank Account is debited immediately and the account balance is updated accordingly. The Biller Merchant's HFC Bank Account is credited immediately with your payment.
- For your next payment, you can access your HFC Bank's Bill Pay Address Book and select the Biller for payment. The amount of payment can be changed if all other details of the Biller Merchant and the Customer Reference Number remains the same.

Disclaimer Statement: Please note it is your responsibility to make your payments in time and HFC Bank indemnifies itself from any cases of incorrect customer input of Biller Reference numbers, overdue payment dates, payment amounts and scheduled periodical payments.

SMS ONE TIME PASSWORD (OPTIONAL SERVICE)

SMS One Time Password provides added security. A 6-digit verification code is sent to your mobile phone at each login to Internet or Mobile Banking.

To activate SMS One Time Password:

- Logon to Internet Banking 1
- 2. Select 'Services & Help' menu
- 3. Select 'Setup Security Options'
- 4. Click on Request Button
- 5. Select a mobile phone number from drop down list
- 6. Select an account where fee is to be charged
- 7. Read and accept the Terms & Conditions
- 8. Click on Request
- 9. Enter Password for confirmation
- Click on Finish. 10.
