


## Foreign Exchange Commentary

FJD strengthened against USD (by 02 points). USD monthly average for this month is at 0.4502. The best importer rate for this month was at 0.4516 and the best exporter for this month was at 0.4664 (USD Importer rate remains the same on a 3 day moving average)



FJD strengthened against NZD (by 01 points), NZD monthly average for this month is at 0.7002. The best importer rate for this month was at 0.7022 and exporter rate was at 0.7303 (NZD importer rate has strengthened on a 3 day moving average)





FJD strengthened against JPY (by 0.16 points), JPY monthly average for this month is 48.13 The best importer rate for this month was at 48.31 The best exporter rate is at 50.86 (JPY importer rate has strengthened on a 3 day moving average).
